After 3 at BCD – After School Program fees are *in addition to tuition*.

BCD families may choose from the following payment options for *After 3:00 at BCD – After School Program*. Please check the appropriate box indicating the billing plan you for which you would like to register. You will be invoiced according to the plan you choose.

- Unlimited Use – \$250.00** per trimester per child with a \$500.00 per trimester cap per family (Note: the \$500.00 cap ensures that families with more than two children enrolled will never pay more than \$500.00 per trimester for our After School Program)
- Pre-Pay 10 Day – \$75.00** - Purchase “Pre-Pay 10 Day” packages for \$75.00. These days may be used with multiple children within one family. However, one “day” is used for each child in attendance. (For example, 2 children in attendance = 2 days used) regardless of the amount of time used.
_____ Number of “Pre-Pay 10 Day” cards you wish to purchase each trimester. (Note: you will be billed at our hourly rate once pre-paid days are used.)
- Hourly - \$8.50/hour per child, per hour** – Students who are not signed up for either the Unlimited Use or Pre-Pay Days options will automatically be billed at our hourly rate. Parents who choose to be billed hourly are charged \$8.50 per hour/per child. We count time used in ½ hour segments.
- Early Bird Early Drop-Off** - For your convenience, BCD also offers an “Early Bird” Before School Program beginning at 7:30 a.m. on regular school days. The home base for this program is located in the art room in the administration building. We offer this service free of charge to BCD families.

After 3 at BCD – After School Program is open Tuesday, August 24, 2010 through Tuesday, May 24, 2011. After School hours are 3:00-5:45 p.m. Note: Boulder Country Day’s Extended Day Program will be closed on the following days:

After 3 at BCD – After School Program fees are separate from After School Specialty Class fees. *After 3 at BCD* Specialty Class fees are listed in our After School Class Catalogues.

If a student who is registered for BCD’s After School Program also wishes to attend an After School Specialty Class, parents will not be billed After School Program fees for time in which a child is in an After School Specialty Class. However, if your child attends BCD’s After School Program before or after an After School Specialty Class, hourly fees will apply and your family will automatically be billed at our hourly rate of \$8.50 per hour, per child for time used - unless your child is signed up for either the Unlimited Use or the Pre-Pay Day billing option.

Children may not be left on school grounds unattended by a parent or guardian before or after school hours. Children left unattended on campus will be brought to either our Before or After School Programs and signed in. Parents will be billed at our hourly rate of \$8.50 per hour, per child for time used.

Late pick-up is strongly discouraged. *After 3 at BCD – After School Program* dismisses daily 5:45 p.m. Please note that beginning at 5:45 p.m., parents will be billed \$1.00 per minute, per child. Parents will be invoiced fees for late pick up charges and payment is due upon invoice receipt. Consistently late pick-up of your child or consistently late payments may result in loss of your child’s place in our *After 3 at BCD – After School Program*.

Before any student may attend *After 3 at BCD*, an After School Program Enrollment Form must be signed by a parent or guardian. Current emergency contact information and medical/immunization information must also be on file. This is a legal contract between the parent and the school. By signing this contract you are acknowledging that you have read and understand the above terms and conditions.

A \$10.00, non-refundable, administrative fee is required with your family’s registration for *After 3 at BCD – After School Program*. This fee is applied per family – not child. The \$10.00 administrative fee must accompany this form.
